ATTENTION! CHANGE IN DESMOS CIRCULATION!

There are currently around 30,000 members of Delta Sigma Delta. Of these, 3,000 are "active", paying annual dues and attending graduate chapter meetings. There are a further 27,000 who pay no dues, do not attend meetings and therefore may be considered "non-active", even though they are all still mailed every edition of *DESMOS*. The Supreme Council has been looking at ways to use the Fraternity funds in a more efficient way and also to attempt to reintroduce some of the "nonactive" members back into Fraternal life. The first step towards this dual aim can be achieved via the distribution of *DESMOS*.

It is now no longer practical or economical to distribute *DESMOS* in the same way as previously. The current method of mailing has been helpful for the Supreme Scribe to ascertain correct addresses – if *DESMOS* is returned he knows the member has moved on. However, the 27,000 "non-active" members who continue to receive *DESMOS* are causing an unsustainable drain on the funds of the Fraternity. It would be poor business practice for the Supreme Council to allow this drain to continue.

In addition, in the modern age it is far more economical and convenient to distribute publications such as *DESMOS* electronically (soft copy) and the Supreme Council is working toward this goal.

If you are one of the 27,000 "non-active" members who does not pay dues through a Graduate Chapter or the Graduate Chapter-At-Large, the Supreme Council would like to try to rekindle your interest in the Fraternity. If you are one of these "non-active" members and would like to continue to receive *DESMOS* and/or would be interested in hearing about other activities of the Fraternity, would you please answer the following questions preferably by e-mail to: supremescribe@deltsig.com or by regular mail to

- **1.** Are you still interested in receiving *DESMOS*?
- 2. Do you have access to the internet?
- 3. Will you agree to pick up *DESMOS* from the Fraternity website?

To continue to receive printed *DESMOS*, you must join an established graduate chapter or the Graduate Chapter-At Large by paying the annual per capita fee of \$45 in the November Loyalty Fund letter, which you receive by regular postal mail.

If you are one of the 3,000 "active" members who pays annual dues, you need do nothing as DESMOS shall still be sent to you.

For the next two years, the June quarterly issue of *DESMOS* shall be mailed to all members, and the three other quarterly issues shall be mailed to members who have paid per capita annual dues for the year.

Digital copies shall continue to be available to all members at www.deltsig.com the Fraternity website. To "Log In", use your last name as "User Name" and then your five digit zip-code as "Password", i.e. the zip-code where you receive the printed *DESMOS*. Once logged in to our website, under "Member Tools: My Account" you may edit your password and your membership information. In the left directory column, click on "Desmos" to read our magazine.

Proposed Changes to DSD BYLAWS

The following changes to BYLAWS are to be voted on at the annual meeting in Orlando this October 10, 2010.

Objectives: Specific dollar amounts for fees need to be changed to a percentage rate so that "cost of living adjustments" can be made incrementally when necessary.

Rationale: The life membership fee of \$100 is the same amount since 1978. Some increase of fraternal fees is long overdue considering the increased costs of living and inflation over the last thirty years. The fraternity needs some flexibility for modest increases in fees when deemed necessary due to future financial circumstances.

Notation: Current text is lined-through and the proposed replacement text is underlined and emboldened.

Changes: From page 29 of BYLAWS OF THE SUPREME CHAPTER:

CHAPTER VI Fees and Dues

Section 1. The life membership fee for each member of an Undergraduate Chapter when entering the Supreme Chapter upon graduation shall be a fee of one hundred dollars (\$100.00) a fee established by the Supreme Council. Each year in January, following graduation, the payment of an annual per capita fee will reaffirm the member's support of the good works of the fraternity and continue the subscription to all issues of the official publication, DESMOS. Graduate members, residing at home or abroad, paying an annual per capita fee through a Graduate Chapter will not be additionally responsible for an annual per capita fee.

Section 2. The initiation fee of each member entering from the profession shall be one hundred thirty-five dollars (\$135.00) determined by the Supreme Council. This fee will establish life membership in Delta Sigma Delta. Each year in January, the payment of an annual per capita fee will reaffirm the member's support of the good works of the fraternity and continue the subscription to all issues of the official publication, DESMOS. A member residing at home or abroad paying an annual per capita fee through a Graduate Chapter will not be additionally responsible for an annual per capita fee.

Changes: From page 47 BYLAWS OF THE UNDERGRADUATE CHAPTER

CHAPTER X Fees and Dues

Section 1. The fee for initiation into an Undergraduate Chapter shall be determined annually by the Deputy Supreme Grand Master of the Chapter.

Section 2. Each initiate into an Undergraduate Chapter shall be required to pay an initiation fee <u>to the Supreme Chapter</u> of ten dollars-(\$10.00); such fee would not apply to the Life Membership fee This fee shall be <u>determined by the Supreme Council and</u> paid in addition to the Life Membership fee. Both fees are to be transmitted to the Supreme Scribe within twenty (20) days after initiation.

Section 3. Each initiate shall pay to the initiating chapter, a life membership fee of one hundred dollars (\$100.00) determined by the Supreme Council, which if not paid in full at the time of initiation, shall be prorated, collected by the Chapter and remitted to the Supreme Scribe in the following minimum installments:

In the event at any time an initiate pays an installment of the life membership fee in an amount greater than the next installment the Chapter is required to remit to the Supreme Scribe, such excess payment received by the Chapter shall be forwarded together with the next required remittance.

Failure of an initiate to pay any installment of the life membership fee within such time as to permit the initiating Chapter to make remittance to the Supreme Scribe in accordance with the above schedule, may be considered evidence of failure of the initiate to consummate life membership.

In the event that the membership of an undergraduate in the local chapter is terminated for any reason, only those pre-paid life membership installments for any year subsequent to the year of termination may be refunded to the undergraduate chapter.

Section 4. An annual per capita fee to the Supreme Chapter is to be determined annually by the Supreme Council. Fees shall be paid to the Supreme Scribe from the Chapter treasury on or before January 20th, for each member of record as of November 1st of the preceding year.

Section 5. The amount of all dues of Undergraduate Chapter members shall be approved by the Deputy Supreme Grand Master.

NATIONAL DENTAL FOUNDATION WESTERN AUSTRALIAN BRANCH

he Western Australian State Coordinator and Chairman and founder of the National Dental Foundation, Western Australian Branch (NDFWA), is Junior Page Bro Dennis Gregory. Bro Dennis is a prominent Oral Surgeon in Perth.

The Mission Statement of the Dental Volunteer Program for Western Australia is "To provide dental care to genuinely underprivileged people to assist them out of immediate dental concern and to maintain a healthy dental condition in their future. NDFWA Dental Volunteer Program also aims to raise community awareness and assist in the overall State (and National) dental crisis".

The objectives of the Dental Volunteer Program include:

- a) Assessing needs in the community in aged care institutions and charity groups like the Salvation Army, St Vincent de Paul Society, and drug rehabilitation programs;
- b) Gaining support from dental colleagues, dental practices, hygienists and dental nurses, and the Australian Dental Association and the Public Health System;
- c) Working up a plan for delivery of services to underprivileged and institutionalised dependent individuals who have no access to usual channels for obtaining dental care, which includes seeking financial assistance from Dental Supply Companies, Charity Groups and the Health Department.

These objectives involve holding charity days at individual volunteer practices that would donate their facility, staff, equipment, and time; along with dentists from other practices who would attend. All would work together on a specified day seeing and treating patients who had been carefully identified by chosen Charity Groups and referred for their specific need and motivation to access this free service. The Program also serves as a link for patients treated in this Program back to the government system. Many of these patients are completely unaware of government services available and how to access those services.

The Program also involves providing support services through a government program to look after the dental needs of institutionalised elderly or disabled residents by:

- a) Dental clinics run by contracted dentists at nursing homes and hospitals
- b) Dentists servicing institutions as private providers
- c) Hygienists employed at institutions to maintain oral health on a routine basis

FINANCES

Dentists, hygienists and support staff volunteer their time.

Materials and resources are provided by a combination of resources from the volunteer participating practices, and materials or financial support donated by companies of the Australian Dental Industry. Additional administration and consultation costs are funded by fund raising activities. National Dental Foundation office bearers or volunteers do not receive payment for their services.

PROGRAM COMMENCEMENT

Once a group of eligible patients had been identified and referred by Charity Groups, the Program commenced by identifying a series of 'volunteer days', called 'Dental Rescue Days'. These are usually on

a Saturday when many practices are usually closed. The practice premises of a volunteer dentist are made available and volunteer dentists with support staff attend the premises and treatment begins. The session usually runs for five to six hours.

Ten 'Dental Rescue Days' have been conducted as of May 2010. Dental Services to be offered include:

- a) Relief of pain
- b) Emergency treatment and prescriptions
- c) Basic oral health treatment
- d) Preventive oral health education
- e) In special cases, at the sole discretion of the NDFWA, further treatment may be offered
- f) In serious cases, assistance with referrals for further treatment

A mutual obligation contract exists between the NDFWA and participating Charity Groups. This contract ensures that, amongst other things:

- a) The Charity Group accepts the responsibility to ensure that only genuinely needy patients are referred to the NDFWA;
- b) All efforts are taken to ensure that appointment attendance is no lower than 90%;
- c) The Charity Group will be solely responsible for the transportation and attendance of patients at the appointed time for treatment.

The NDFWA reserves the right to withdraw its volunteer dental services from a Charity Group that fails to abide by the agreed conditions, and to offer the services to another Charity Group.

The final 'Dental Rescue Day' for 2009 was held in November. However, the week before that, The Western Australian State Government provided the loan of a mobile dental clinic – a caravan, which enabled our volunteers to set up a clinic in the Perth City Centre. This day coincided with one of the periodic 'Homeless Contact Days' conducted by the Perth City Council, days on which many other types of volunteer services converge on the city to assist the homeless. Many homeless people do congregate in the city, and our team of volunteers were kept very busy all day and provided treatment to sixty-four people. Many of these patients presented with a high degree of infection and/or pain, which was easily resolved by extracting a tooth, and about 100 teeth were extracted on that day. Patients were offered further treatment at the next scheduled 'Dental Rescue Day' on the following Saturday.

In 2010 a 'Dental Rescue Day'was held on 13 March, and at the time of writing (20 May 2010) the next is due to be held on 19 June. Another will be held in August. The NDFWA will again participate in the 'Homeless Connect Day' conducted by the

Perth City Council in November, which will be followed a week later by the last 'Dental Rescue Day' for 2010.

The NDFWA is also liaising with Bro John Owen and his 'Kimberley Dental Team', referred to an earlier issue, regarding his separate humanitarian program conducted in the northwest of Western Australia, 1500 kilometres north of Perth. Bro Dennis took a team of five volunteers on the trip in May to assist the Sisters of Mercy in the Gibb River region by providing dental treatment to disadvantaged and indigenous people in this outback remote area. A clinic was to be set up at the Gibb River Nursing Post. The Nursing Post will be using equipment, instruments, and materials donated by Dental Supply Companies, private donors, and dentists. Severe flooding curtailed their activities, however, and they were forced to return. Their planned return in August 2010 is expected to be brought forward. It is hoped to be able to staff this clinic twice a year utilising the generosity and willingness of our Volunteer Dental Team.

In summary, the metropolitan Perth program has been treating the homeless, deserted parents and their children, street kids, people on alcohol and drug rehabilitation programs, and those who for various reasons are unable to manage their own affairs and rely on charity groups. There are 9 different organised charity groups that NDFWA liaises with. Volunteer staff involved include:

- a) 60 Dentists
- b) 72 Dental Assistants
- c) 30 Administration staff
- d) 10 Hygienists
- e) 5 Dental Therapists

A fund raising "Big Night Out" Cocktail Party is scheduled for Saturday 3 June 2010, to be held at fashionable Frasers Function Centre in King's Park overlooking the beautiful Swan River.



 $\mathcal{F}_{ ext{or some months before our April meet-}}$ ing, GM Geoff Pullen had been using every opportunity to emphasise its significance, and his exhortations (he repudiates the phrase "veiled threats") inspired a markedly increased attendance. The topic for the evening was "The ADA and the Community" and the formidable quartet of speakers consisted of four past Grand Masters - Bros. John Matthews, Lloyd O'Brien, David Houghton and Neil Hewson. The catalyst for the evening's theme was the comprehensive review and reorganisation of the health professions by the Federal Government and, specifically, the implications for the future delivery of dental services throughout Australia.

Collectively, the four speakers represented a wealth of service to the profession and the community and a reminder of the role that members of the Fraternity have played in leadership within the profession. Each brought his own perspective to the topic and the result was a wide-ranging examination of the Government's proposals and their effect on the practice of dentistry.

PGM John Matthews outlined the elements of ADA policy, which included the primary role of prevention in the form of fluoridation and oral hygiene promotion, targeted care directed at children, adolescents, the aged, the indigenous and special needs groups. He argued persuasively that this would represent far better value for the community than a scheme involving universal coverage.

PGM Lloyd O'Brien brought a wealth of historical perspective to the discussion, emphasising the long-standing crisis in funding for dental education and the deficiencies in health planning that focused on short term results, leading to a lack of continuity in care. These deficiencies usually resulted from health planners ignoring advice from those who actually delivered the services. He also drew attention to the unfortunate fact that, in this age of self-promotion and advertising, we are encouraged to compete against each other, and called for a return to true professionalism. His conclusion - we have nothing to fear from a well-constructed health scheme; it could

advantage both dentists and patients.

PGM David Houghton took us through an international comparison of dental health care delivery, with various combinations of private and public funding, and an examination of the various funding projections for an Australian scheme. He also emphasised that there was insufficient workforce and facilities for a universal scheme and that the appropriate model should be a comprehensive plan targeted to disadvantaged groups.

PGM Neil Hewson, the current Federal President, summed up the discussion, reiterating the ADA's position. In regard to the ethos of the profession, he echoed the sentiments of many who practised before the advent of advertising when he stated that the application of competition policy to dentistry was a serious error. The loss of self-regulation and the depiction of dentistry as purely a business has not been to the advantage of either the community or the profession.

Any dentist who graduated from the dental school of the University of Melbourne between 1984 and the beginning of the 21st century would have been taught by Bro. John Harcourt. In addition, Bro. John has an extraordinary record of service to the profession through his long involvement with the ADA and its numerous committees at both state and federal level, with the Royal Australasian College of Dental Surgeons and as editor of the Australian Dental Journal. When Bro. John Rattray had completed the long list of service and achievements, GM Geoff then presented Bro. John Harcourt with the Victorian Chapter's Certificate of Appreciation, to a standing ovation. Bro. John replied with characteristic modesty.

GM Geoff also mentioned that he had recently spoken with Bro. Gary Nervo who was taken ill several years ago and who has been enduring serious complications in his illness. GM Geoff advised that, despite the seriousness of his illness, Bro. Gary is delighted to receive calls and that his sense of humour is alive and well.

Srother David Booth, our Worthy Master, and the founder and convenor of the 'Christian Health Aid Team' (CHAT), referred to in a recent feature article in Desmos (2008 V.114-2, pgs 10-13), has received a further honour. Brother David was invited to deliver an address to a joint meeting of five Rotary Clubs held recently in Perth. The subject of his address was the humanitarian work carried by him and his 'Team' in Vietnam. Following the meeting and address Brother David was recognised as a 'Paul Harris Fellow'. The award was made 'in appreciation of tangible and significant assistance given for the furtherance of better understanding and friendly relations among peoples of the world'.

The 'Paul Harris Fellowship' was founded in 1957 in memory Paul Harris, a lawyer from Chicago, and the founder of Rotary International in 1905. The 'Fellowship' confers an expression of appreciation for those who have contributed to the Foundation's humanitarian and educational programs. Rotarians designate a 'Paul Harris Fellow' as a tribute to a person whose life demonstrates a shared purpose with the objectives of the Rotary Foundation. Recipients receive a lapel pin and certificate that identifies them as advocates of the Foundation's goals of world peace and understanding. After more than 50 years, recognition as a 'Paul Harris Fellow' remains a respected and prestigious honour.

As an added bonus Brother David was presented with the award by past Grand Master of our Chapter, Brother Peter McKerracher. Brother Peter is a past District Governor of Rotary.

Brother John Owen AM, who has been referred to in recent issues, and about whom a major article is being prepared, has also received a very prestigious honour. In the recent Queen's Birthday Honours List, Brother John was awarded Membership of the Order Of Australia (AM). (Brother John joins his father, Brother Ray Owen, as a recipient of the AM). The citation states for 'services to the specialty of orthodontics and a range of leadership roles within the dental profession'. Details of these numerous leadership roles were documented in Desmos (2009 V.115-2, pg 15). But Brother John's contribution does not stop there.

Brother John and his wife Jan are well down the track with the development of their Kimberley Dental Team (KDT), referred to briefly in Desmos (2009 V.115-4, pg 15). This marvellous humanitarian program is taking dental services to indigenous and disadvantaged persons in the remote northwest areas of Australia 2,500 kilometres from Perth. A major article will be published following the 1 Sept 2010 deadline.

Historian's Report

James Plescia – our truly fraternal friend



"Jim Plescia! I've known him since we were boys!" exclaimed Br Martin Piekos to me at a recent dinner meeting. Our wonderful friendship with gracious Jim spans decades. As a young deputy of Rho

Chapter, since the 1980's I got to know Jim through the many, many get-togethers and pizza-parties Jim generously sponsored so we could assemble for fun and to learn the latest technologies for dental practice. Jim's special knowledge and experiences have helped countless dentists in Chicagoland and northern Illinois. A recent, enormous accomplishment of Jim's is the state-ofthe-art group practice he equipped for Br Dennis Collins, who with four dentist colleagues and twenty personnel operate the beautiful sixteen-operatory Collins Dental Group, featured in the Patterson Today Winter 2009 magazine and at www.collinsdentalgroup.com Indeed, Jim's professional associations reach across the country. I added chapters and dates to some of Jim's recollections of his professional connections with Delta Sig fellows, but Jim's words tell his story:

"My relationship with Delta Sigma Delta began in 1981. At the time I worked for Frink Dental Supply Company. I was a service technician and wanted to become an equipment specialist. The owners of Frink Dental Supply, John DiPietro and Tom Cavanagh said that they did not need another equipment specialist. However, they knew the importance to have a representative from Frink make contact with the students and help with their transition from dental school out into the real world of private practice. Thanks to their insight and for giving me the opportunity to be a student representative, I began building relationships that would last a lifetime.

"At the time, in Chicago there were three dental schools, University of Illinois College of Dentistry (Rho Chapter), Loyola University School of Dentistry (Beta Chapter), and the Northwestern University Dental School (Eta Chapter). Each dental school had approximately 150 students per class. Since I didn't know anyone and I really didn't know what to do, I asked some of the instructors to point me in the right direction. They suggested that I contact the student presidents of the dental fraternities and they could help me to coordinate times to present our products and the services that a full-service dental supply company could provide. As it turned out Delta Sigma Delta Fraternity had the largest membership chapters and they were very receptive to my presentations.

"Many of the Delts were instrumental in helping me put on the presentations. For my start with Beta Chapter members at the Loyola School, I owe a big "Thank You" to Marty Piekos (Beta,'81), who spent a lot of time making sure that I had

a good attendance at the "PUB" at Loyola, where we would dine after my product and equipment presentations. Marcel Krawczyk (Rho,'82) and Larry Kolar (Rho,'82) helped to organize our meetings and parties at the Rho Chapter fraternity house at 720 S. Oakley, near the Illinois College of Dentistry. At the time Dr Joe Allgood (Eta,'50), a professor and adviser for Eta Chapter of Delta Sigma Delta at Northwestern, helped me get acquainted with the Eta members. At Northwestern, Vance Carlson (Eta,'82) was instrumental with introducing me to the right people and helped me co-ordinate the Delt outings. Vance introduced me to one of his classmates, Dennis Collins (Eta,'82). I have designed and equipped all three of Dennis' offices in Sycamore, Illinois. More importantly Dennis introduced me to my wife and has been a true friend all these years.

"The following are just a few of the many highlights of my time supporting the Delta Sigma Delta Fraternity. At each chapter over the years I gave many presentations on the latest equipment, supplies and office design. The casino nights at the Rho Delt house and gatherings at Jimmy Gees were always big hits. The students would buy products with the play money that they won. Kevin Kopp (Rho,'85) was always the big winner at U of I. The products distributed as prizes and gifts were donated by many generous manufacturers.

"We took road trips to Dr Ron Reichls' office. Dr Reichl (Rho,'66) would give us a tour of his office, talk about how he got

started in practice and answer any questions that the students had. Everyone really liked how his treatment rooms wrapped around the beautiful atrium with a banana tree and real live monkey. I would also take small groups of students to Mr Bob Fine's home. Bob Fine was a living legend with the Kerr Company. Bob would do hands-on demonstrations on the proper way to mix up a batch of Permalastic impression material. Then Bob's wife would serve up homemade apple pie and ice cream. With the help of Tom Hoover (Rho,'83) I installed a lab handpiece assembly in the basement of the Rho Delt house. One year after a Northwestern golf-outing, I had the Delts back to my house for a BBQ party, when someone actually wore his steel golf spikes in my house on my hardwood floor.

"The first year that I started calling on the schools was in 1981. So by the time the class of 1985 graduated, I knew almost everyone on a first name basis. I was there to assist with their future plans - whether it was finding an associateship position, buying a practice, or setting up a brand new office. It was a win-win situation. Our supply salespeople would ask me to refer them to recent graduates who would be interested in associating, buying or transitioning into one of their accounts' practices. Also we would do the demographics of certain areas that would be good locations to set up a practice. Many of the Delts that I helped find an associateship or helped them find a practice to buy are now turning to me to help them hire an associate or direct them to the right people to help them sell their practice.

"From the early 1990's to the present time I am an equipment specialist for PATTERSON DENTAL in Chicago, helping dentists to expand and equip their existing offices, to design and equip new offices, and to incorporate new technology in their practices.

"The dental field is truly a relationship business. All of networking and friendships that I have made through my association with the Delta Sigma Delta Fraternity have been very rewarding and fulfilling. I enjoy especially seeing the dentists that I met early on in their careers do well in their practices. Now I am even helping their sons and daughters with their equipment needs as they join their parents' dental practices.

"It has been an honor and pleasure to serve Delta Sigma Delta."



DR WADE P. CALVERT 100 Years of Dentistry over Four Family Generations

The Calvert family was pictured on the cover of ADA News – Jan. 4, 2010, in celebration March 2009 to commemorate the centennial of the 1908 graduation from Northwestern University Dental School of Dr James Rex Calvert – their father, grandfather and great grandfather. Br Wade P. Calvert (Zeta 1951 Univ. California San Francisco) was seated between the parchment diploma and graduation class photograph of his father Dr James Rex Calvert. Standing behind the seated Br Calvert were his children and their children – all in dentistry: Jenny Clavert, R.D.H., Dr Jason Calvert, Dr Scott Calvert, Dr Randy Calvert, Dr Kevin Calvert, Dr Dennis Calvert; Dr Terrak Calvert, and Natasha Calvert, R.D.H.

ADA News reporter Arlene Furlong told of the family dental heritage and their total of 239 years in the dental profession between them all! Dr Wade Calvert, now 85 years of age, loved dentistry and influenced his four sons to follow in the profession: Dr Dennis Calvert became a periodontist and Dr Randy Calvert an endodontist, Dr Scott Calvert and Dr Kevin Calvert are general practitioners. A fourth generation of Calverts has begun in dentistry: Dr Dennis Calvert's son, Dr Terrak Calvert, is a periodontist and his youngest daughter, Natasha Calvert, is a registered dental hygienist. Dr Scott Calvert's daughter, Jenny Calvert, is also a registered dental hygienist and his son, Dr Jason Calvert, is an endodontist.

To mark the centennial, the Calvert family established the Calvert Dental Heritage Foundation, which gives back to the community in volunteer dental education and offers scholarships to aspiring dentists and health care professionals.

Dr Wade Calvert's father, Dr James Rex Calvert, studied at the Northwestern University Dental School with famous faculty members Dr G. V. Black and his son Dr Arthur Black. Br Wade Calvert recalled, "My dad practiced for 65 years, and he did it while standing up the whole time. I stood for 15 years. Much of it is hard to believe when I think about it now. I practiced for 50 years, and I hope my sons and grandchildren will achieve the 50-year pinnacle of pride. I believe they all will follow because we love to work with people and love our profession."

DR DONALD E. DEMKEE UA Board Chairman Emeritus receives National Fraternity's Top Honor

The University of Akron announced on April 26th in a press-release by Sarah Lane, Dr Donald Demkee, chairman emeritus of The University of Akron's Board of Trustees and a 1960 graduate of the University, was honored by the Phi Delta Theta with its most prestigious recognition, the Raymond L. Gardner Award for 2009. Dr Demkee is only the third Akron graduate to receive the honor. The annual award is presented to a distinguished alumnus who has made the most significant contribution to the fraternity, his community and the world of higher education.

Br Donald Demkee is a native of Barberton, OH, and earned his D.D.S. at The Ohio State University (Mu Mu Chapter 1965). As a maxillofacial surgeon he practiced from 1971-1999 in the Wooster area. Desmos 2009 V. 115 – 2, p. 8 reported with Br Don's photo a short biography and his award of honorary Doctor of Humane Letters by The University of Akron's board of trustees.

Br Don is a lifelong supporter of higher education and has devoted much time and energy to his undergraduate alma mater by serving on and leading its Board of Trustees. He continues to volunteer his services to professional and community organizations at local, state and national levels, as he did throughout his career. He has funded a variety of student scholarships, including the Demkee Scholarship of Phi Delta Theta Fraternity and four internships for University of Akron students in the Ray C. Bliss Institute of Applied Politics. His generosity extends to other educational institutions with scholarships to St Mary of the Immaculate Conception school in Wooster, the Cleveland Diocese school system, and The Ohio State University, and funding the Demkee Medical Library at the Wooster Community Hospital.

Br Don Demkee and his wife, Imogene, live in Wooster. They have two adult sons, Samuel and Andrew.

DR TERRY D. DICKINSON

2010 ADA Humanitarian Award and Missions of Mercy

Dr Terry Dickinson (Tau Tau Chapter 1967 University of Houston) is to receive the 2010 ADA Humanitarian Award in Orlando in October for his work as founder and director of the Missions of Mercy Project, as reported by Stacie Crozier on page 12 in the ADA News - January 4, 2010, entitled "Missions of Mercy is his life's mission." Br Dickinson spent thirty years in private dental practice, while serving on leadership posts in dental organizations and working as a dental educator, examiner and researcher. He began serving as executive director at the Virginia Dental Association (VDA) in 1999 and during the first Mission of Mercy event, he realized he found his life's mission.

Br Dickinson's enthusiasm and devotion to founding the Virginia MOM Projects have led to more than a dozen states launching MOM programs, estimated to become twenty operating programs nationwide by 2010.

Indeed, recently on June 11- 12th, the Illinois State Dental Society Foundation's Illinois Mission of Mercy event was the biggest first-time ever MOM held since they began in 2000, providing over \$1 million in free dental care in the huge multipurpose banquet and conference center at Bloomington, IL. 1953 patients, mostly adults and about 40% reporting in pain, received free dental care services that included cleanings, topical fluoride treatments, sealants, fillings, extractions, root canals fillings, lab work and antibiotic and pain medications, as reported by Stacie Crozier, ADA News - June 21, 2010. Dr Brad Barnes of Bloomington and Dr Mark Humenik of Northbrook, IL, co-chaired the event supported by 1000 dentists, dental hygienists, dental assistants, dental lab technicians and other volunteers, including Dr Thomas E. Sullivan (Beta 1994 Loyola University), ADA first vice president and a general dentist in Westchester, IL. The Illinois MOM was supported by nine major contributors: America's Dentists Care Foundation, Delta Dental of Illinois, Chicago Dental Society Foundation, Interstate Center, Patterson Dental, Illinois State Dental Society Foundation, DentaQuest, Dentsply, and Downstate Society Caucus, and nearly 100 other supporters including dental companies, community organizations, local business and local dentists. How wonderfully and generously has Dr Terry Dickinson's mission continues to grow and to become evermore widely adopted and supported across our states!

When Dr Dickinson founded the MOM, then VDA President Charles I. Cuttino remarked, "He will be known as the man who opened peoples' eyes that there is an access problem in this country and that opened doors to individuals and legislative bodies to help provide a solution to the problem. He is truly a humanitarian." (ADA News – Jan. 4, 2010)

Dr Robert Lowe's handsome visage graced the cover of Dentistry Today, Vol. 29 No. 5, which included his clinical report on aesthetic restorations, entitled "No-Prep Veneers: A Realistic Option." Br Bob presents many half-day and all-day continuing education programs at dental society meetings across the United States during the year. This September 10th for the Illinois Dental Society, for example, he is scheduled to present "Clinical Solutions for a Profitable Practice", a program on refining dental preparations and impression-taking skills for consistently high-quality treatments. He will discuss how new technologies of dental lasers and digital impressions can augment clinical restorative treatments. Br Bob's presentations are always top-notch and stimulating with many clinical tips for effective practice.

Since graduating magna cum laude from Loyola University School of Dentistry in 1982, Br Robert Lowe (Beta Chapter) has taught dentistry at every opportunity. He served as assistant professor in operative dentistry until Loyola closed in 1993. During those years when he was the Chicago Graduate Chapter Representative of Delta Sigma Delta, he spent many evenings instructing the young Delta Sig student-members of Beta, Eta and Rho Chapters of Chicago in restorative dentistry techniques and principles. Br Bob would bring plenty of instruments and filling materials for his instructional programs so the students could try the techniques and materials that he demonstrated. Br Bob would critique their work and instruct them in details for quality restorative technique. Student Delts truly got "hands-on experiences" when Br Bob instructed during after-class hours with members at the three dental schools. Even during those early days of dental practice, Br Bob had teaching in his blood, imparting to his young students the highest ideals of dentistry.

In January 2000 Br Bob moved to Charlotte, NC, where he has a private practice. He lectures internationally and publishes widely on aesthetic and restorative dentistry, and he is clinical evaluator of materials and products. Br Lowe received Fellowships in the AGD, ICD, ADI, and ACD. At the Chicago Dental Society Mid-Winter Meeting, he received the prestigious 2004 Gordon Christensen Outstanding Lecturers Award. In 2005, he was awarded Diplomate status on the American Board of Aesthetic Dentistry.

COLUMBIA — Funeral service for Dr John Owens Bumgardner was held Thursday October 15, 2009, at First Presbyterian Church of Columbia. Burial followed in Crescent Hill Memorial Gardens.

Dr Bumgardner, a D.D.S., was a native of Columbia. He was the son of the late Dentist Dr E.G. Bumgardner and Margaret Anne Callaham Bumgardner. A Navy veteran of WW II, he attended Columbia High School, University of South Carolina, graduated from Presbyterian College and received a D.D.S. degree in 1956 from Emory University, where he joined the Theta Theta Chapter of Delta Sigma Delta Fraternity. He returned to Columbia and practiced dentistry for thirty-seven years. Dr Bumgardner, a fellow of the American College of Dentists, served in a number of professional organizations. He was past president to the Southern Academy of Oral Surgery, Carolinas Section of the American College of Dentists, Greater Columbia Dental Association, Central District Dental Society, S.C. Academy of Dental Practice Administration and the Mid Carolina Study Academy. He also served on the

South Carolina Board of Dental Examiners, Advisory Board of Governors, and Medical Advisory Committee to the Department of Social Services and was the S.C. Dental Association representative to the Health Education Authority of the Commission on Higher Education.




